Hydration A-Plus® is a long-lasting mineral acid-based Plant and Soil Hydrating Agent that dissolves bicarbonates which makes calcium available and in turn displaces soil sodium.

Hydration A-Plus® contains Salicylic Acid (SA) which will improve the plant's ability to recover from heat and drought stress.

Directions For Use:

Greens, Tees and Fine Turf:

Apply 0.75 - 1.5 oz. of **Hydration A-Plus®** with 1 - 2 gallons of water per 1,000 sq.ft. every 1-2 weeks. Apply the 0.75 oz. rate on a 1-week schedule or 1.5 oz. rate on a 2-week schedule. Rinse in product with 3-5 minutes of irrigation that evening.

Fairways, Roughs Sports Turf, Lawns:

Apply 0.25 - 0.5 gallon of **Hydration A-Plus®** with 44 - 88 gallons of water per acre. (0.75 - 1.5 oz. with 1 - 2 gallons of water per 1,000 sq.ft.) every 2 - 4 weeks during the growing season on warm, transitional and cool season grasses.

Mixing & Handling: Ensure adequate ventilation and/or wear an approved respirator. Clean mixing & application equipment. Fill tank ¾ full with water; begin adding one product at a time. Use a proper mixing order (W.A.L.E.S). Always check mixture compatibility by using the jar test method first.

Caution: Keep away from children & domestic animals. Do not apply product near water, storm drains or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/ garden.

Sodium Flush Application:

Apply 2 - 4 oz. of **Hydration A-Plus®** with 4 - 6 oz. of Plant Food Co's **Sugar Cal 10%** with 1.5 - 2 gallons of water per 1,000 sq.ft. Irrigate immediately for 20 minutes.

Correcting Localized Dry Spots (LDS):

Apply 1 - 3 oz. of **Hydration A-Plus®** with 1.5 - 2 gallons of water per 1,000 sq.ft. Irrigate immediately for 15 minutes. Follow up with 0.75 oz. rate on a 1-week schedule or 1.5 oz. rate on a 2-week schedule.

Low ET Rate: If the growth rate is minimal apply 0.35 oz. of **Hydration A-Plus®** with 1 gallon of water per 1,000 sq.ft.
